



## PLANNING AND ZONING COMMISSION PUBLIC HEARING / MEETING INFORMATION

The deadline for complete applications is five weeks prior to the desired Planning and Zoning (P&Z) Commission hearing / meeting date. Unless they are cancelled, meetings take place on the second Wednesday of each month at 5:30 p.m. in the Village Board Room located on the second floor of Village Hall, 1 Friendship Plaza, Addison, IL.

**Variation-only** requests are reviewed and decided by the P&Z Commission. **All other requests** require review and recommendation to the Building, Zoning, and Development (BZ&D) Committee before Village Board (VB) consideration and final decision. These include requests for pre-annexations, annexations, rezoning, special uses, planned developments, and zoning code and text amendments.

Petitioners are required to attend the public hearing/meetings before the P&Z Commission and the BZ&D Committee. Attendance is not required at the VB meetings, but recommended.
